PREFACE

The National AIDS Control Organisation's (NACO) annual report (2016-2017) gives the total number of People Living with HIV (PLHIV) in India, in 2015, as 21.17 lakhs. The same year, undivided Andhra Pradesh had the highest estimated number of 3.95 lakh PLHIV.

Telangana recorded 11,846 new cases of HIV and AIDS in 2016, with the capital, Hyderabad alone accounting for 33 percent of the caseload in the state. The total population of people living with HIV (PLHIV) in the state, stood at 1,73,398 as of January 1, 2017, as against 1,61,552 cases in 2015.

Cheyutha, meaning, "helping hand" in Telugu, was established in 2005 with the support of LEPRA Society in Hyderabad. The Women's Community-Based Organisation (WCBO) is a women's community initiative for and by women living with HIV/AIDS, for care and support services with a special focus on women and children infected and affected by HIV/AIDS. Cheyutha has been rendering various care and support services such as counselling; referrals to Antiretroviral Therapy (ART) centres; free treatment for opportunistic infections (OIs); foster care for orphan children; educational support to infected and affected children; arranging positive marriages; taking up legal issues and fighting for the rights of the deprived and vulnerable women, with a special focus on empowering women to lead dignified lives. Cheyutha has so far benefited a total of 1888 women through its services.

After a successful association with Cheyutha since 2005, LEPRA Society decided to transfer the project management to the CBO in 2011. In 2016, Cheyutha and LEPRA Society signed a MoU whereby the CBO became an independent body. As a long term measure, both realised the need to mobilise resources for continuation of the work and sustainability of the CBO. The formulation of the 'resource mobilisation strategy' was undertaken with financial support from HIV/AIDS alliance to guide the process of fundraising.

🎒 Accomplishments 2016 - 17 🎒

Clinical Services

• Cheyutha enrolled 1888 PLHIV to access clinical services for Opportunistic infections (OIs); conducted 52



weekly clinics; provided clinical services to 204 regular members and 18 children; recorded 14 new registrations; tested 196 patients referred for cluster of differentiation

4(CD4); 242 CD4 follow-ups registered 161 PLHIV for ART; and completed 1209 follow-ups of regular members

- The CBO volunteers referred 167 general cases for HIV testing; enrolled 3 members found positive in ART centre for treatment and counselled 11 members who were ART defaulters to continue therapy
- Registered a total of 933 antenatal referrals of which 5 were found positive and enrolled in the mother to child transmission (MTCT) programme. Two cases were referred to a counsellor at Gandhi Hospital. Eleven antenatal cases (positive), both old and new, were followed up and 7 of them delivered and received ART and Nevirapine was administered to mother and baby; 2 of them underwent medical termination of pregnancy (MTP) and 7 mothers followed-up along with babies for their polymerase chain reaction (PCR) test and 2 are still in antenatal clinics (ANC)
- Eighty four members were referred to the Care & Support

centres in Medchal; 657 persons visited the walk-in centre and availed different kinds of services at Cheyutha in Gaddianaram, Hyderabad

Support Group

- Received training to become positive speakers
- Participated in the World AIDS Day, December 2016
- Observed International Women's Day
- Two members received sewing machines; 5 members were given financial support for developing their petty businesses
- The 60-member, strong support group saved ₹ 59,200 during 2016-17
- 6 members received training in jute bag making under the livelihood programme

Educational Support



Cheyutha received 56 applications for educational support and a total of 70 children who are infected and affected are being supported under the program. A total of ₹ 2,86,540 has been raised towards educational support. Two children are being accommodated in hostels.

Linkage with International and National Agencies

- UNICEF: Twenty four Cheyutha support group members got an opportunity to work with UNICEF on the special Inactivated Polio Vaccine (IPV) drive programme, from June 15th, 2016 to July 5th, 2016. They were part of an awareness drive and actively managed IPV booths
- SAATHII: Cheyutha was chosen by SAATHII (an NGO which works to strengthen and expand HIV/ AIDS services), for conducting the pilot project in interactive voice responsive system (IVRS). Text alerts were sent to pregnant women for prevention of parent to child transmission (PPTCT) services and follow-up. Fourteen antenatal and postnatal mothers attended the meeting

Social Support Programme

Support for marriages: Cheyutha received 33 applications from HIV positive persons wishing to get married and helped four couples tie the knot!

Resource Mobilisation


• CASH and KIND: In 2016-17, Cheyutha focused on fundraising activities and mobilised ₹ 8,68,140 in



cash and also raised in-kind donations like medicine, clothes, blankets, books, groceries, feminine hygiene products and stationery

Mr. Papa Rao, Chairman, Indian Red Cross and Advisor to Chief Minister, Telangana, made a generous donation in kind, by handing over ownership of a generic medical store, to Cheyutha, on International Women's Day, 8th March, 2017

Profitable Enterprise: A jute bag enterprise started by Cheyutha in March 2016, with support from



trained in the skill. Manepally Jewellers placed an order for 44 bags; Catholic Health Association of India (CHAI) ordered 120 bags; Society of Jesus, Mary, Joseph (JMJ) placed an order for 75 Jute bags; a birthday return gift

order of 50 bags; Christmas return gift order of 50 bags; 10 tambulam (traditional return gifts) bags for a customer in the United States of America. To date, the said initiative has taken 6 orders and set up 3 exhibition stalls which were held at Gandhi Hospital Auditorium; Blue Peter Health Research Centre (BPHRC) and ITC Agri Foods. Cheyutha earned a profit of ₹ 50,240 in 2016-17



Outreach Activities

Conducted 51 group meetings in ART Centres where nearly 1561 members have been counselled on regular follow-up of ART; low-cost nutrition; importance of CD4 testing; personal hygiene; pre-ART registration and positive prevention; safe sex practices and enrolment in ART pension.



Chevutha also:

- Supported 16 foster care children with monthly food provisions
- Resolved 6 out of 11 existing legal cases through Legal Aid services and received 7 new cases
- Provided nutrition support to 356 members
- Received 81 applications for ART pension from members, of which, 63 received pension as a result of continuous follow-up with Telangana State Aids Control Society (TSACS), by Cheyutha volunteers

An event for educational support was conducted on 18th August 2016, at Cheyutha, Gadiannaram. The

HEconomic Empowerment


- Cheyutha launched a socio-economic rehabilitation (SER) scheme for its members with a revolving loan
- fund. This allowed members borrowing funds to repay the amount in small instalments and the accumulated deposit was made available to other needy women who were running self- sustained businesses.

Success Stories

• Suvartha, an ART defaulter, suffering from a kidney infection was dismissed from school when the

management became aware of her HIV positive status. Cheyutha extended timely support to Suvartha by getting her treated at Niloufer ART centre and Osmania General Hospital and providing nutritional support. When Suvartha recovered, she wanted to go back to school, but her parents feared that she would be rejected as she had been discriminated earlier. But on seeing Suvartha's unhappiness over not being able to attend school, they decided to send her to a private school. Suvartha's father was visually impaired as a side-effect of ART and her mother, also HIV positive, being the only earning member



made it tough for them to pay tuition. With the support of LEPRA Society, Cheyutha was able to find a donor who sponsored Suvartha's admission to a private school and she completed second grade, in April 2017, with an A plus! Suvartha and her parents are very happy with the outcome!



- Divya, a HIV positive, foster care child, supported by Cheyutha, was identified as a beneficiary for a government entitlement for the handicapped. A volunteer at Cheyutha worked very hard to get Divya a set of callipers and a Software for Assessment of Disabled for Access Rehabilitation and Empowerment (SADAREM) certificate for handicap pension, which included free travel by train/bus and air. Eight-year-old Divya is now a student of first grade at school!
- Nineteen-year-old Manasa (name changed), diagnosed with HIV when she was five months pregnant, was referred to Cheyutha by BPHRC. Counselling revealed that she had acquired it from her parents. Her older sister had leprosy but tested negative for HIV. Manasa's husband who tested negative abandoned her and she decided to abort the pregnancy as she had no support. Cheyutha intervened and helped her register at the Gandhi Hospital for prevention of mother-to-child transmission of HIV (PMTCT) and ART centre for Medication. But Manasa decided to undergo MTP. She eventually started working at an electricity meter manufacturing factory and is also



pursuing her undergraduate studies through the Open University. A young Manasa leads a fruitful life despite all her personal losses!

• **Pushpa,** a widow who lived with her brother, was thrown out when her health started deteriorating and she was suspected to be HIV positive. She lived on the road side begging for her



survival. Infested with worms and wounds all over her body, she was emaciated and her condition was deplorable. Pushpa caught the eye of the Shivrampally Primary Health Centre (PHC) coordinator who took her to Osmania Hospital, where she tested positive for HIV. The coordinator visited her once a week and took her to Osmania Hospital and also approached many NGOs, Shelters and AIDS Control Society to admit Pushpa for treatment, but was unsuccessful. The AIDS Control Society then referred her to Cheyutha. The Cheyutha team took up the case and after many refusals finally found CHAI which agreed to get her admitted in Sneha Kiran Care and Support Centre, in January, 2017. Pushpa is now living in Shivrampally in a rented place and is doing good!
