I am proud to present the 2020–2021 Annual Report of Cheyutha, reporting on activities that were undertaken during this year.


Coronavirus (Covid 19) swept across the world in 2020 and created havoc in every continent. Many households have felt its devastation, joblessness, and lockdowns.

The COVID-19 pandemic and the ensuing lockdown restrictions caused unprecedented delays in our activities that were scheduled. Government offices and public transports were closed from April to September 2020.

Unfortunately, the pandemic pushed many of our members infected/affected by HIV/AIDS further deep into poverty due to an increase in expenditure and loss of income/daily wages.

Despite some of these challenges, we were able to provide our regular services with the help of APPI (Azim Premji Philanthropic Initiatives). We managed to access ART and Link ART centres for the required amounts of medicines and made sure they reached our members on time. In some cases, we also provided dry ration whenever it was feasible.

In addition to this, we made ourselves available to assist our members with necessary information and counseling that was required to alert them about Covid 19 since HIV/AIDS patients are easily susceptible to other diseases.

Cheyutha continues to grow — and as we grow, we are evolving to improve the on-the-job experience for staff and volunteers.

Poor and marginalised groups often do not have the same rights as other groups in the society and they are less able to access information and health services that will help them prevent HIV/AIDS.

We enhanced our response to HIV/AIDS by increasing both activities and financial disbursements.

So far we have been able to provide dry ration, grocery and nutrition (Jaggery, peanuts and sesame) supplies for 15 children and 70 support group members.

Support Group

Support group members meet on the second Thursday of every month. Clinical check ups and group counselling on positive living are held.

Besides assisting HIV/AIDS infected patients with the ART medicines, our members also have access to FREE medicines such as antibiotics (required to fight against seasonal and fungal infections such as Diarrhea, Vomiting, Fever etc.), immunity boosters, iron, vitamin and calcium tablets that we procure from the funds we receive through donations.

Members pay a nominal membership fees of Rs 150 per annum and avail the FREE clinical and medical facilities.

The membership fee gives a sense of belonging and results in not only accessing services but volunteering to help others and to participate in advocacy activities

Stories of Hope - I

1. Venkatamma (name changed)



I come from a lower middle class family. I got married when I was 21 years old in 2005. My husband was not physically well built, he was lean and often fell sick. Within two months after I got married, my life took an unfortunate turn, I became a widow.

Dealing with the loss was a big struggle for me and during that time I was not keeping good health. Various tests and examinations revealed that I was HIV positive.

Those 60 days of my marital life changed my life upside down

I was devastated when I learnt about the disease, I felt alone and scared. Those 60 days of my marital life changed my life upside down. I was too scared to disclose the disease to my family members. The social stigma that was attached to HIV/AIDS made it even more difficult for me.

We paid hefty amounts of money (considering our standard of living)

I had no choice then but to seek help from my younger brother. We went to a private hospital and started my medication there. We paid hefty amounts of money (considering our standard of living) for ART medicines and private consultations.

I often felt guilty for being a burden on my family, often I suppressed the complications I suffered due to HIV/AIDS and other seasonal infections that I was prone to. Hope appeared in sight when we learnt about Cheyutha.

My health began to deteriorate badly during the 4-6 months lockdown that was imposed due to the rise in Covid cases in 2020. I could not go for my consultations. Government at that time changed the ART medicines from ZLN to TLD and these I could not procure from private medical stores.

Hope appeared in sight when we learnt about Cheyutha through some network of contacts. One of the Cheyutha outreach workers gave me counseling and guided me with necessary actions. I was advised to go to Malakpet hospital, get HIV Tested (this report was a mandate to avail ART medication for free). There a full health medical examination was done for no cost, Cheyutha staff also assisted me to Osmania hospital a few times which enabled the periodic supply of ART medicines for me.

I can say with certainty that my health has improved.

I was put on a revised medication. I now take my TLD - ART and other medications regularly.

I enrolled myself and became a member of Cheyutha for proxaliation treatment.

I can say with certainty that my health has improved and I have gained more confidence to fight the disease now.

I am grateful to Cheyutha for all the counseling they had given and for assisting me with my treatment. Listening to others made me realise that I am not alone in this and together we can win this battle one day!

2. Latha (name changed)

I was tested HIV positive a few years ago . Last year during the months of Sep-Nov 2020, I developed severe stomach pain and was quite sure that I had developed some urinary tract infection. It was difficult for me to urinate and I put up with unbearable pain.

Each specialist suspected some serious issue like Cancer.

My real ordeal started when I had to make multiple visits to Gynecology, Urology and Surgical departments at MNJ, Osmania and Gandhi hospitals. Each specialist suspected some serious issue like Cancer. No one could say anything for certain until the Biopsy was done. I was put through a series of tests including abdominal scan and endoscopy.

Finally I learnt I was diagnosed with Incisional Hernia.

At one point I was referred to Osmania hospital and I was admitted there for over 20 days, many more tests were done but when it came to Biopsy, I was told their test equipment was not in working condition.

I then went to Gandhi hospital, where various scans and tests were conducted again. Finally I learnt I was diagnosed with Incisional Hernia.

I was referred back and forth between the General surgery and Urology departments at Gandhi hospital. Both departments refused to do the surgery and I was advised to go back to MNJ hospital.

The ordeal again came back to the same starting point - "without a Biopsy, even they could not help".

I came in contact with Cheyutha and the staff immediately assisted me to Gandhi hospital.

With the influence and reputation Cheyutha had with Gandhi hospital, we could directly meet the superintendent Dr. Raja Rao. We detailed to him my situation and the ordeal I went through.

I once again received immense help and support from Cheyutha.

He extended the necessary support immediately. My Viral load copies were

high and I was advised to be on second line medications to get the virus count under control.

I once again received immense help and support from Cheyutha with identifying ART centers and the registration process for the second line treatment.

Once the virus count levels come under control, required surgical procedures will be done. I wish I had known about Cheyutha long ago. But better late than never, I am thankful to my stars for getting me in touch with Cheyutha now.

May the staff and volunteers at Cheyutha be given more strength and support to continue the incredible work they are doing for people like us.

My prayers are always with them!

Counseling

Counseling is part of a holistic approach to the patient's overall health care.

Cheyutha has long served as a hub for the HIV/AIDS workforce and community to come together, learn and share. One of the key works involved here is counseling.

We believe that right counseling and guidance motivates people to lead a healthy lifestyle.

HIV/AIDS infected/affected people need care, support and guidance to live a positive life.

Psycho-social support and proper nutrition has been identified as an important component parallel to treatment (both ART and treatment for opportunistic diseases).



Registration and counseling service at the clinic At Cheyutha we identified two general aims in HIV/AIDS counseling:

1) the prevention of HIV transmission and

 the support of those affected directly and indirectly by HIV/AIDS.

We ensure our counseling meets these dual aims. The spread of HIV/AIDS can only be prevented by changes in behaviour.

We offer one to one counseling for it enables frank discussion of sensitive aspects of a patient's life—such discussion may be hampered in other settings by the patient's concern for confidentiality or anxiety about a judgmental response.

Also, when patients learn that they are infected with HIV/AIDS, they often suffer great psycho-social and psychological stresses due to fear of rejection, social stigma, disease progression, and the uncertainties associated with future management of HIV/AIDS.

We make sure good clinical management practices are put in place in order to manage such situations with consistency and professionalism.

At Cheyutha, the staff involved in counseling are given formal counseling training and receive regular clinical supervision as part of adherence to good standards of clinical practice.

Counseling during ART medications is one other important area where members need a lot of support.

Taking a complicated drug serves as a constant reminder of HIV/AIDS

infection. The presence of side effects can often make patients feel more unwell than did HIV/AIDS itself.

Sometimes our members are unable to cope with the side effects. Counseling has helped members adjust to complex daily routines of medication. Our counseling aims to give people the information and life skills they need to make decisions about their future.

Stories of Hope - II

1. Deepa (name changed)

My life took many adverse turns. I was married in 1995 and was blessed with a son and a daughter.

My husband often fell sick and did not lead a healthy life. After nine years into our marriage my husband was diagnosed with HIV positive and he died in 2004.

My son and I were tested HIV positive too.

On doctor's advice, we also got our tests done. My son and I were tested HIV positive too. I came in contact with Cheyutha in 2006, they gave us family counseling and other necessary support. We were put on ART medications.

In 2017 another misfortune hit our lives. My son died that year due to TB.

My health began to deteriorate ever since. I was admitted to private hospitals three times. Tests revealed that there was water retention in my brain and I also suffered from TB as my son did.

Within months I had my second TB attack.

I was put on heavy medications. I felt better for some time, but within months I had my second TB attack. I lacked nutrition rich food and my maiden family could not extend their support due to their own financial constraints.

My viral load and CD4 counts showed erratic increase and due to that I have now developed Vascular Headache.

The medicines cost around Rs 20,000 which I could not afford.

I was advised to be on medication for 6 months. The medicines cost around Rs 20,000 which I could not afford.

I approached Cheyutha for help and with the support from APPI they are now assisting me with financial support and medical care under emergency service. I hope to lead a positive life and do due justice for all the support I am receiving through Cheyutha!

2. Mamta (name changed)



I am a widow and a single parent of two children (son and daughter). My husband died due to HIV/AIDS about 15 years ago. My son and I were also tested positive. I am physically handicapped and I get a meager pension from the AP state government. My elder sister was of utmost support to us. I was on a lookout for support and did not want to burden my sister.

I learnt about Cheyutha in 2006, ever since then they have been supporting us with medicines, dry ration and nutrition supplies.

They also help my children get education scholarships.

In addition to this Cheyutha helped me set up a roadside fruit stall in Moti Nagar and extended financial support of Rs 10,000 through their livelihood initiatives.

Our Life was going well until I met with a serious road accident near Suryapet.

This happened early last year when I was returning from my hometown.

Covid cases were on rise and government hospitals were not in a position to take other cases and hence I was admitted to a private hospital.

Cheyutha gave us Rs 15,000 during my hospitalization. Necessary procedures were done. Due to the internal damages my left hand has become dysfunctional. I still suffer with pain.

I am deeply indebted to Cheyutha for all their support. I am doing much better now and my children are pursuing their education well.

We will be indebted to Cheyutha for all of our lives!

Foster care



Cheyuta supports initiatives for orphans and other vulnerable children in Hyderabad and Rangareddy district.

In the past few years, the need for interventions has become more obvious as the number of orphans was increasing and the burden on the elderly had become acute and severe.

Many are growing up with low self-esteem and little sense of security.

Our immediate concern for these children was to provide support for their educational, physical, and psychosocial distress.

Some children who have lost either or both parents due to HIV/AIDS live with relatives or old grandparent(s).

Foster care children receive nutrition kits every month.

Educational Support

We work alongside HIV/AIDS infected/affected families who need access to health care and education.



Cheyutha believes that no HIV/AIDS infected/affected member should be deprived of visiting a doctor or sending their child to school.

In the year 2020 - 2021, we enrolled about 44 children (against the target of 20), who were malnourished, underweight, and with opportunistic infections. So far we have been able to support 36 children with their education.

In addition to this we have applied for 42 more student applications for government scholarships with the "Women and Child Welfare Department". These applications are under process.

Covid-19 pandemic forced closure of schools with a shift to online classes eventually.

The schools continued to charge fees even after the shift towards online classes to support their staff salaries and administration costs.

The Pandemic pushed many of our members infected/affected by HIV/AIDS further deep into poverty due to an increase in expenditure and loss of income/daily wages.

As a result many families could not afford to pay the school fees.



We saw it as our responsibility to rise up to that situation and take necessary remedial measures to mitigate the hardship suffered by students and their parents.



Over the years Cheyutha has been implementing the Educational Support Program with the contributions from APPI and Individual donors Mr. and Mrs. Usha Gummalla and Dr. Krishna Kiran from Medicover Hospital.

We would not have succeeded without their support!

Stories of Hope - III

1. Naresh (name changed)



I lost both my parents who were diagnosed with HIV positive. My father

died when I was 5 years old and my mother died last year i.e. in 2020.

I was also diagnosed HIV positive when I was 12 years (I am now 19 years).

Had my mother started her ART medicines earlier, she probably would have survived.

My mother knew about Cheyutha since 2008. In Spite of repeated counseling and advice given by Cheyutha, my mother refused to take ART medicines fearing the society and the side effects that came along with it.

She had her own apprehensions and fears and due to that she did not allow me to take the medicines too. Two and half years ago, my mother succumbed to a serious problem in her uterus. She lost a lot of blood due to that and her uterus had to be removed. Cheyutha extended their support immensely despite my mother's firm refusal to take ART medicines. They helped her get admitted in the hospital and assisted her during and post surgical recovery.

Had my mother started her ART medicines earlier, she probably would have survived.

As a child I did not keep a very stable health. There were a few occasions when I had to take long breaks from going to school. I used to be underweight and not very strong physically. Rarely have I seen someone show such a deep concern for a complete stranger.

Cheyutha supported us through their counselling programs and insisted that I start my ART medications. They would often say to me, "you are young and have a whole life and the opportunity to lead a happy and healthy life". Rarely have I seen someone show such a deep concern for a complete stranger.

My grandmother and I live together, we look after eachother.

I am on ART medications now and in good health and spirits. We receive grocery and nutrition diet supplies from Cheyutha. My grandmother and I live together, we look after eachother. We have a small piece of agricultural land in Nalgonda and I help my uncle with his poultry business. From these sources we get some income for our sustenance. In addition to this we also receive dry ration supply from Cheyutha.

I am truly grateful for the self-less services we receive from Cheyutha.

I have a flair for education and fortunately because of my interest and desire to rise above the poverty that we are in, I was able to do well in school and college. I am currently pursuing a three year degree program - B.Com Computers. I am truly grateful for the self-less services we receive from Cheyutha.

I hope to excel in my life and give back to society to the best of my ability!

2. Navya (name changed)

I am 8 years old and tested for HIV positive recently.



My mother died in 2013 when I was 3 months old.

I was told that my parents had differences of opinion and severe clashes. My father left us after I was born.

I lost both my parents, my grandmother looks after me.

My grandmother is a widow and she looks after me. We come from an economically weak background.

My grandmother works as a domestic maid in people's houses and does some tailoring to fund our everyday expenses. It was confirmed that I am infected with *HIV/AIDS*.

Growing up I suffered many infections and health issues. After a few visits made to the doctors at private and government hospitals, it was confirmed that I am infected with HIV/AIDS.

We learnt about Cheyutha last year and they have been helping me with treatment and medications ever since.

They also support us with dry ration and nutrition supplies.

Cheyutha has promised to extend educational support as well!

Legal Assistance



Free legal aid for socially and economically vulnerable people was introduced across India in 1995, when the Legal Services Authorities Act came into force. The law is aimed at ensuring justice for all on the basis of equal opportunity, and one its key provisions mandates offering free services of lawyers who volunteer their time for pro bono cases to those who cannot afford to pay.

We at Cheyutha were fortunate to have found some kind secretary/ cum civil judges from Hyderabad and Range Reddy districts who genuinely help the needy receive the benefits that they are entitled to.

Over the years we have noticed that women and young girls are more vulnerable and are, today, at a greatest risk and subjected to domestic violence.

Most members of Cheyutha not only battle with HIV/AIDS but also fight against the discriminatation and deprivation they face at their marital homes. This year nine such cases were documented at Cheyutha. Eight cases are still pending in court, one was resolved through legal intervention and counseling.

Advocacy Campaigns

NACO (National AIDS Control Organisation) has signed Memorandum of Understanding with the Ministry of Housing & Urban Poverty Alleviation, Government of India, with the objective to reach out PLHIV and affected population with enhanced accessibility in the livelihood schemes and programmes.



This was signed to improve social protection to PLHIV and Most at risk population (MARPS) through existing schemes and programmes for urban employment, poverty alleviation and housing.

Based on this information, we approached Hyderabad and Rangareddy District Collectors with a petition requesting allotment of houses for women living with HIV/AIDS.

We received a response from the Rangareddy Collector. He ordered their respective Mandal Revenue Office (MRO) to process our requests made for the allotment of houses. We sent 25 applications in Hyderabad District, 16 in Rangareddy District and 10 in Medchal District. (Total-51 applications were sent for two bedroom houses)



Schedule Caste Loans are provided by the government to start small petty businesses. HIV/AIDS infected people are given higher priority in receiving the loans faster.



From Cheyutha nine members applied for SC loans, one among them, Mrs. Bavamma was sanctioned 1 Lakh for starting a petty Kirana (provisional) store, loan amount of Rs. 50,000 is under process for four members and the remaining four members' applications are pending from the government.

We are doing the necessary follow ups to get the updates on all the applications.

Leadership, Training and Outreach activities

Leadership

It is said that having the best interests and bright ideas is not enough, to make things happen and get things done one has to effectively engage with people and bring them together in ways that help them achieve common goals.



Competent individuals perform irrespective of leadership position, but

when there is effective leadership they reach new heights.

At Cheyutha efforts are made to develop second line leadership. Youth below the age of 35 years were identified who can manage and run the organization with the help of mentors.

Training

Training programs were conducted on the organization policies. We drafted and developed Conflict of Interest policy, Finance policy, HR policy, Prevention of Sexual Harassment of Women at Work Place Policy and Child Protection policy. Cheyutha support group members, board members and Staff participated in Organization development training programme conducted by Dr.V.Rukmini Rao, and Dr.Indira.

Outreach activities

WLHIV members of Cheyutha regularly visit ART and Link ART Centers for treatment.

Outreach activities are held at ART centers, Link ART centres and PPTCT centres to promote the wellbeing of men, women and children who are infected with HIV/AIDS. They encourage them to take medicines regularly and educate them on low cost nutrition.



Our outreach activities typically include

- New ART registration
- Enrolment for PPTCT
- Enroll for ART pensions
- Referring HIV/AIDS patients to Care and support centers
- Follow up home visits to check the treatment update, foster care and education support
- Visits to Government offices and partner NGOs

Through our outreach programs, members receive regular medical support and once a week visit to the clinic at Cheyutha on Saturdays.

Members are given counseling on a regular basis regarding the ART opportunistic infections, treatment and low cost nutrition. Where the case demands, we refer them to emergency health care services like hospital admission, blood transmission, emergency surgeries and ART registrations.

Events

World AIDS day 2020



World AIDS Day, observed each year on December 1, is an opportunity for people worldwide to unite in the fight against HIV, show their support for people with HIV, and remember those who have died from an HIV-related illness.

Today, it is regarded as the longest-running disease awareness initiative of its kind in the history of public health.

Due to the Covid-19 pandemic, this year we organised the event in a small and simple scale.

Fundraising

Cheyutha is now fully compliant with statutory requirements, this year we submitted our details to auditors and have received our TAN number HYDC11475C.

It has been 18 long years of struggles and efforts in serving as a voice for people living with HIV/AIDS. We would not have sustained it if it was not for the ongoing support of our mother organization LEPRA Society, Indian Red Cross Society, TACS and our well wishers.



Now with the additional support we received from APPI and other donors we plan to expand our outreach and support more people infected/affected by HIV/AIDS. We aim to reach 600 members by the end of 2025. Until 2019 we had been able to support only fewer members and children.

During this FY 2020-2021 our team has put tremendous effort into raising funds and building relationships with our supporters. We are now able to plan ahead, update our supporters on consistent progress of our activities.

Besides the support from APPI, we received CSR funding from ADP (Automatic Data Processing) towards Education, Nutrition, and medical support for HIV/AIDS infected/affected children. We continue to maintain our partnerships with LEPRA Society, Indian Red Cross Society, TSACS, Value Labs, ADP, Joy Group, Change foundation, NCPI+, Ranganatha Rao Foundation and local donors.

We thank Shri. L.Shashidhar Reddy from Trisara Investments LLP, for supporting us with Rs.200,000 every year and special thanks to our partners and donors for extending their help especially during this crucial COVID situation.

Jute Enterprise

The JOY Group established the Jute Enterprise to assist Cheyutha in becoming self-sufficient. The unit, which launched in 2016, began the work with 3 machines, 10 women were trained to make bags. Individual orders are still handled by the group, and they continue to participate in exhibitions.

Due to Covid-19 and the lockdowns, we were unable to display our products and as a result received no sales. During this period, the staff and members designed new products using the resources we had in the workplace.

Moving forward, we wish to use this initiative to connect with our supporters and generate revenue.

This year we have disbursed some funds in training programs given to the board members and volunteers, and towards upgradation of office infrastructure.

In the near future, we plan to use some more funds for website development and digital marketing for better outreach.
